§ 1 General Terms and Conditions

• The user submits a request to enter into an agreement for the free use of the game by registering and logging into the game; by doing so, they declare that they agree with these General Terms and Conditions by providing their email address.

• These General Terms and Conditions form the basis of the User Agreement. By logging into the game, the user confirms that they have read and understood them.

• The Operator is not responsible for the loss or blocking of an account if another player with the same IP address or HWID violates the rules.

§ 3 Exploiting Bugs, Scripting, and Cheating

• No activities that enable cheating or disrupt game mechanics are allowed.

• Automatic and semi-automatic scripts that perform database queries or trigger game mechanisms are explicitly prohibited.

• In case of violations, the corresponding account will be deleted or blocked without prior warning.

- Legal actions may also be taken.

- Checks are conducted randomly or based on reports.
- It is forbidden to impersonate another user, support member, community manager, or the Operator or to threaten other players with sanctions on their behalf.

• Inappropriate texts in character descriptions, guild texts, or game messages may lead to account suspension or deletion.

• Rules are enforced by a team consisting of administrators, game moderators, and support staff.

• All communication with the team must take place through the official Discord.

• Attempts to circumvent the decision of an authorized team member by presenting the same issue to another member may result in account suspension or deletion.

• Upon logging into the game, data that allows the unique identification of the user is collected.
